



STATEMENT OF FEES

Simple Legal Ceremony Cost: \$300

Services provided in This Fee include:

- Initial booking meeting at my home office with the couple.
- Complete NOIM (Notice of Intended Marriage)
- Fulfilment of all necessary legal requirements.
- Unlimited phone/e mail support where required.
- Pre-written short and legal ceremony.
- Wedding ceremony on the date of your choice (Monday to Friday only), at my home office.
- Registered postage of your legal documents to Births Deaths & Marriages, Adelaide.
- Ceremonial certificate of marriage.
- Just you and your witness (whom I can provide by arrangement).

Simple Weekday Elopement: \$450

Services provided in This Fee include:

- Initial booking meeting at my home office with the couple.
- Complete NOIM (Notice of Intended Marriage)
- Fulfilment of all necessary legal requirements.
- Unlimited phone/e mail support where required.
- Pre-written short and legal ceremony.
- Wedding ceremony on the date of your choice (Monday to Friday only), at my home or yours or other local place by arrangement.
- Registered postage of your legal documents to Births Deaths & Marriages, Adelaide.
- Complementary presentation book of your ceremony in pocket style booklet.
- Ceremonial certificate of marriage.
- Unlimited guests as appropriate.

Custom Written Wedding Ceremony Cost: \$800

(\$100 discount for weekdays)

Services Provided in This Fee Include:

- Planning and writing of a customized ceremony in accordance with your instructions.
- Unlimited meetings with the couple.
- Complete NOIM (Notice of Intended Marriage)
- Fulfilment of all necessary legal requirements.
- Unlimited phone/e mail/face to face support where required.
- Research into required readings/rituals or music.
- Manual including brochures for relationship services, sample ceremonies and vows, and optional wedding symbols and rituals.
- Use of my PA system, my table and two chairs for signing if required, and of any other decorations I may have.
- Wedding rehearsal at ceremony location.
- Wedding ceremony at your chosen location. Travel included within 50km radius.
- Registered postage of your legal documents to Births Deaths & Marriages, Adelaide.
- Complementary presentation book of your ceremony to suit your theme.
- Local travel costs (for further than 50km from my home see other costs)
- Ceremonial certificate of marriage.

Vow Renewals and Commitment Ceremonies: \$400

Services Provided in This Fee Include:

- Planning and writing of a customized ceremony in accordance with your instructions.
- Unlimited meetings with the couple.
- Unlimited phone/e mail/face to face support where required.
- Research into required readings/rituals or music.
- Manual including brochures for relationship services, sample ceremonies and vows, and optional commitment symbols and rituals.
- Use of my PA system, my table and two chairs for signing if required, and of any other decorations I may have.
- Ceremony at your chosen location.
- Complementary presentation book of your ceremony to suit your theme.
- Local travel costs (for further than 50km from my home see other costs)

Additional Services That May Incur Extra Costs:

- Want a friend to run your ceremony? Co-piloted ceremony: **\$150 Discount!**
- Want to be my only booking for the day? Exclusively yours: **\$200 surcharge.**
- Travel over 50km from my home \$1 @ km.
- Public Holidays & Public Holiday Weekends: \$100 surcharge at my discretion.
- Provision of coloured sand (for Ritual ceremony): \$5 per person & colour.
- Toll or parking fees if applicable.
- Costs involved in setting up any required rituals (including but not exclusively candles, sand, wine etc.)
- Travel and accommodation expenses out of the Adelaide CBD.
- Changing a Simple Ceremony to a Custom Written Ceremony – charges will apply at my discretion.
- Rehearsals over 50km from my home may incur an additional travel fee.

ADDITIONAL FEE & INVOICING INFORMATION

Fee Policy

1. A \$200 non-refundable booking fee is required to secure my services as your celebrant. This must be paid at the time of filling out the NOIM (Notice of Intended marriage) and/or at our first meeting.
2. The balance of fees is payable at your rehearsal or at least one month prior to your ceremony (whichever comes first)
A reminder will be sent out, and ceremonies will not take place without full payment being received.
3. Payment can be made by cash or bank transfer
4. An invoice will be provided for approval and signature of the couple, this secures pricing and your date.
5. Waiting time at Rehearsal and or Ceremony – For excessive lateness of an hour or more from the agreed start time there will be a minimum of a \$50/hour charge at the Celebrant's discretion, payable within 5 business days to ensure lodgement of all legal documentation to Births, Deaths and Marriages.
6. In the case of a ceremony being postponed/cancelled, this schedule may become null and void.

Refund Policy

1. Postponement:

If new date is to be within 18 months booking fee will be held over to new date (NOIM is valid for 18 months).

Couple are responsible for any costs incurred in postponing. A new invoice will be written up, to be negotiated between couple and celebrant.

2. Cancellation by couple:

In the event of cancellation, no later than one month prior to the ceremony, any funds (except the non-refundable booking fee) will be refunded in full.

In the event of cancellation within one month of the ceremony date, any refund of the balance or part thereof paid is subject to negotiation and at the discretion of the celebrant and will be dependent on work already carried out.

3. Cancellation by celebrant:

In the event that I am unable to attend a ceremony 100% of funds paid by couple will be refunded. Or if required/possible and/or relevant, an alternate Celebrant will be found as a replacement.
